**MEMORANDUM OF UNDERSTANDING (MoU)  
BETWEEN

ELECTROCUS SOLUTIONS, LUCKNOW**

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on the 17<sup>th</sup> day of November Two Thousand Twenty One. (17/11/2021)

**by and between**

**Department of Electrical Engineering, R.R. Institute of Modern Technology**, the first party represented herein by K.P. Yadav its Head of Department, **Department of Electrical Engineering, R.R. Institute of Modern Technology**, NH-24, Bakshi ka Talab, Sitapur Road, Lucknow, and **Electrocus Solutions** having its office at Thedi Pulia Chauraha, Kursi Road, Lucknow, Uttar Pradesh (226021) . The Second party is represented herein by its Proprietor Mr. Mahfooz Ahmad.

WHEREAS:

- A) First Party is a Higher Educational Institution named **R.R Institute of Modern Technology** and the second Party **Electrocus Solutions** is engaged in providing Electrical and Electronic Solutions.
- B) First party & Second party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enthusiasm opportunities.
- C) The parties intent to focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial visits, Expert Lecture.

**NOW THEREFORE IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**CLAUSE 1: CO-OPERATION**

Both Parties are united by common interests and objective, and they shall establish channels of communication and co-operation. First party and Second party co-operation will facilitate effective utilization of the intellectual capabilities of both the parties. The parties shall co-operatives with each other shall as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents as may be required to give effect to the actions contemplated in terms of this MOU.

**CLAUSE 2: SCOPE OF THE MOU**

The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

**2.1 Industrial Training & Visits:** Industry and Institution interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its projects and also involve in Industrial Training Programs for the First Party. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.

**2.2 Internships and Placement of Students:** Second Party will actively engage to help in by providing and assisting in Internship and Placement of students of the First Party into internships/jobs, as per AICTE internship Policy. The Second Party will also

register on AICTE Internship Portal for disseminating the Internship opportunities available with them.

**2.3 Skill Development for Students:** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

**2.4 Guest Lectures:** Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the latest technological trends and in house requirements.

**2.5 Industry Supported Labs-** The Second Party will set up industry supported lab in consultation with First Party in order to train the students in various aspects of engineering and other skills that will enable them to stay ahead in their field. The industry supported lab will be established in such a manner that it will provide practical knowledge to students that will support them in Industry.

**2.6 Faculty Development Programs:** Second Party to train the faculties of First Party for imparting industrial exposure/ training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.

Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein.

There is no financial commitment on the part of the R.R. Institute of Modern Technology (RRIMT), Lucknow the First Party to take up any program mentioned in the MOU. If there is any financial consideration, it will be dealt separately.

### **CLAUSE 3: VALIDITY**

This Agreement will be valid for a period of 5 years commencing from the date of agreement. The term may be extended for further period by mutual consent in writing by the parties. The agreement can also be terminated before the validity period by any party intimating the other party in writing.

### **CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES**

It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any



authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MOU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at Lucknow court. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Lucknow.
